

With early detection and treatment, prognosis for those with glaucoma, cataracts, macular degeneration or diabetic retinopathy is often more favorable and medical costs are better contained – a top concern for employers and employees alike.

- ... provide a savings of up to \$2,000 per year for glaucoma patients.^{/1} Similar savings are seen with hypertension.
- ... prevent or restore vision loss from cataracts.
- ... reduce the risk of diabetic retinopathy by an estimated 56%./2
- ... halt the progression of macular degeneration. While there is no cure currently for Age-Related Macular Degeneration, regular eye health exams can help manage one's risk.
- ... educate members on other prevention, treatment, management and rehabilitation options.

Enhanced Program Features Disease Management

Diabetic Outreach Program

DavisVision's Disease Management Program offers more specialized components such as our Diabetic Outreach Program which offers increased outreach and communication along with expanded coverage to members with diabetes. No prior approval is required.

Diabetic Outreach Program capabilities include:

Tailored Benefit Plans:

- More frequent eye health exams and enhanced eyewear benefits for diabetic members
- Flexibility to work with pharmacy benefit managers, health plans, disease management vendors and other appropriate third parties to receive and administer separate enrollment and eligibility indicators for diabetics (following HIPAA guidelines)

Coordination of administration and communications with other existing disease management programs including:

- Targeted communications mailed to members throughout the year that encourage visit to eye care provider to receive eye health examinations.
 Annual exam reminders are sent with personalized local provider listings
- Telephone outreach to program members who have not yet used their benefit during the plan year

Provider Outreach

- Education on client program startup and specific plan coverages
- Real-time notification and outreach on appropriate standard of care for identified members
- Notification forms and process for sharing eye health examination results with primary care physicians

Enhanced Reporting/2

- Program management reports with utilization and enrollment results and trends
- Summary encounter reports with relevant procedure/diagnostic codes
- Comprehensive member eye health data and encounter reporting to client's health plan, disease management vendor or other appropriate third party to facilitate HEDIS reporting and other wellness programs
